- Grants to institutions and agencies of the South Carolina Synod of the ELCA and for missions of the ELCA at home and overseas.
- Grants to members of Good Shepherd Lutheran Church for the purpose of attending an ELCA Seminary, for church-related leadership conferences, or such other training which enables members of this congregation to grow in Christian faith and service to God's people.
- Grants for non-budgeted special projects of Good Shepherd Lutheran Church not normally funded by the congregation's annual budget.
